- 6. **The Debt-Ridden (Al-Gharimin)** Those burdened by debts they cannot repay.
- 7. **In the Cause of Allah (Fi Sabilillah)** Humanitarian and relief efforts in accordance with Islamic principles.
- 8. **The Wayfarer (Ibn As-Sabil)** Stranded travellers in need of assistance.
